ORDER:

The Director of Horticulture submitted that Govt. vide Memo No.5250/Agri.II/2018, Dt. 20/08/2018 has identified Horticulture Department as Nodal and implementing agency for implementation of National Bamboo Mission and nominated the Director of Horticulture for anchoring the state Bamboo Mission and also as Mission Director, State Bamboo Development Agency and directed to submit proposals for constitution of various committees as per GOI guidelines.

2. Further he submitted that as per the operational guidelines, each state has to set up Bamboo Development agency at State level headed by the Mission Director and members from concerned departments such as Forest, Agriculture, Industries & Rural development etc. and also to constitute District level agency to oversee, coordinate & control the activities at State level and District level respectively for non-forest areas and private area (farmers lands) also.
3. In addition to the above, a State Level Executive Committee (SLEC) headed by Chief Secretary of the State and having representatives from departments of Agriculture, Industries, Forests, State Agricultural Universities, ICAR Institutes, grower's associations/ FPOs and experts (from processing/designing & product development, industrial promotion and marketing) to be constituted to guide the policy and implementation of the National Bamboo Mission in the State.
4. The Govt. of India vide their Lr.No.25-07/2018-NBM, dt.28.08.2018 has emphasised on constitution of SLEC for implementing the scheme in Telangana State and also for submission of annual action plan for the year 2018-19 duly approved by SLEC.
5. In this regard, Director of Horticulture submitted that, instead of establishing a separate society/agency for implementation of NBM, as the composition and objectives of Society for Horticulture Nurseries (SHN) duly incorporating the objectives of NBM in addition to the existing objectives as was already included earlier for implementation of MIDH programmes by considering the Govt. orders issued vide ref. 1st cited (copy enclosed for kind perusal). However, in view of dire necessity and urgency for submission of approved Action Plan to GoI, the approval of the General Body of SHN for modifications and inclusion of NBM will be obtained in due course.
6. In view of the above context, he requested to accord permission to incorporate objectives of NBM in SHN in addition to the existing objectives in the Memorandum of Association to implement the programmes and mandate of National Bamboo Mission, subject to obtaining ratification of the general body of SHN to be held in due course.
7. Further, Director of Horticulture also requested to issue necessary orders duly constituting the following committees to oversee the implementation of National Bamboo Mission programme at State and District level.
8. After careful examination of the matter the Government issues the following orders for constitution of State Level and District Level Executive Committees.
9. The proposals to incorporate objectives of National Bamboo & Society for Horticulture Nursery in addition to the existing objectives in the Memorandum of Association to implement the progress and mandate of National Bamboo Mission, subject to ratification of General Body of SHN are approved.

A. State Level Executive Committee (SLEC):

Functions of SLEC:

The SLEC has to monitor and oversee the following:

- i) Preparation of perspective and annual State Level Action Plan in consonance with Mission goals and objectives in close coordination with Bamboo Technical Support Group (BTSG) and oversee its implementation, clear project based proposal requiring approval of Executive Committee (EC).
- ii) Monitor receipt of funds from National Bamboo Mission, State Government and other sources for carrying out the Mission activities, maintain proper accounts thereof and submit utilization certificates to the concerned agencies.
- iii) Furnish periodic progress reports to SLEC for onward transmission to the NBM (DAC&FW), Ministry of Agriculture.
- iv) Release funds to the implementing organizations and oversee, monitor and review the implementation of the programmes.
- v) Assist and oversee the implementation of the Mission's programmes in the State through Farmers Societies, NGOs, growers, entrepreneurs, associations, self-help groups, State institutions and other similar entities;
- vi) Oversee, monitor and implementation of the programmes.
- vii) Organize Workshops, Seminars and skill development/ training programmes, participation of artisans in exhibitions / trade fares etc. for all interest groups/ associations at the State level.
- viii) Oversee, operationalization of information communication Technology (ICT) enabled Management Information System (MIS).

The SLEC shall meet every quarter and chairman of SLEC is empowered to convene the meetings as and when required.

B. District Bamboo Mission Committee:

At District level, District Bamboo Mission Committee (DBMC) will be responsible for carrying forward the objectives of the Mission for project formulation, implementation and monitoring.

Functions of DBMC:

- i) Approval of District Annual Action Plan based on the requirements and Specific needs of the Districts.
- ii) Ensure coordination between line Departments.
- iii) Approval of identified farmers list under different State Bamboo Mission (SBM) schemes.
- iv) DBMC shall oversee and monitor the progress and implementation of SBM scheme

- v) Ensure the organisation of trainings, Seminars and exposure visits to the identified farmers under different schemes.
 - vi) Monitor submission of Monthly progress reports to SBM head office.
 - vii) Financial approval for release of assistance to the beneficiaries who have implemented the SBM schemes.
11. The DBMC shall ensure smooth function linkages among different agencies and meet as frequently as possible.
 12. The Director of Horticulture & Sericulture will take further necessary action.
